Placer County registered voters in the Foresthill Public Utility District should start checking their mailboxes for the June 21, 2011 Special District Election Sample Ballot Pamphlet. Sample ballot pamphlets will begin to mail on May 12, 2011.

The sample ballot pamphlet will provide voters with important information about the Foresthill Public Utility measure to be voted on this election. In addition, your polling place location is listed on the back cover of your sample ballot pamphlet. It is important to look at your polling place location as it may have changed. However, if you are a permanent vote-by-mail voter, your pamphlet will read *Permanent Vote-by-Mail Voter* in the polling place location area of the pamphlet. There is only one polling place for this election. The polling place is the Foresthill Veterans Memorial Hall located at 24601 Harrison Street in Foresthill.

For voters who are not permanent vote-by-mail voters, the back cover of the sample ballot pamphlet can be used as a vote-by-mail ballot application. Simply sign the form and return it to the Placer County Office of Elections. Remember, if you are a Permanent Vote-by-Mail Voter, a request for a vote-by-mail ballot is *not* necessary. You will automatically receive your ballot in the mail.

Vote-by-mail ballots will begin mailing on May 23, 2011. You can either use the vote-by-mail ballot request form on your sample ballot pamphlet or download a request form from the Office of Elections website at www.placerelections.com. To ensure sufficient processing time, the last day by law that the Office of Elections may mail a voter-requested vote-by-mail ballot is June 14, 2011. You may pick up a vote-by-mail ballot in the office from May 23, 2011 through Election Day, June 21, 2011. The Office of Elections is located at 2956 Richardson Drive in the DeWitt Center in Auburn. Regular

office hours are Monday through Friday, 8:00 AM to 5:00 PM. Election Day hours are 7:00 AM to 8:00 PM.

If you do not receive your sample ballot pamphlet by June 6, 2011 or if you misplace your sample ballot pamphlet, please contact the Office of Elections at 530-886-5650 or toll-free in California 1-800-824-8683 for a duplicate sample ballot pamphlet.
